 - Secretary of State web site, Articles of Incorporation, original or old Board Minutes, Previous Loan, Church Checking Account, Business License, Federal Tax ID, Church Charter, Dunn & Bradstreet Report, Tax Exemption Certificate, etc.
- Mortgage or Landlord Reference
- Equipment List General list and amount with the application (Fill in above box OR fax quotes)
- Church needs to be listed in the Phone Book/Directory Assistance

Needed To Pay Vendor:

- Resolution or Minutes to show the lease is authorized Include name of person/s authorized to sign the lease
- State and/or Federal Tax Exemption Certificate
- Insurance Binder Please provide your insurance contact info • We need an insurance binder to fund. LFCI will call your agent if you prefer.

New and/or Non-Denominational Churches

- May require pastor's personal guarantee and credit report • Include name of person/s authorized to sign the lease
- Rates are contingent upon:
 - Financial statement analysis, time in business, borrowing history, denominational status, etc.

Basic Minimum Church Qualifications

- Average bank balance over \$5,000
- Minimum 150 members
- Church Age Verified by **one** or more of the following:
 - Sec. of State, D&B Report, Checking Account, Business License,
 - Federal Tax ID, Articles of Incorporation, Church Charter, Old Loan Documentation
- Bank and trade references (over one year in history)
- Mortgage or landlord references (unless you own your building)

Special Payment Programs

- Choose your own payment for the first 12-24 months
- \$20 Check delivers your equipment
- Skip-payment program for slow months (June/July/August)
- \$99 per month for the first six to twelve months

Lease To Own Benefits

- Start-up churches to \$40,000 (more in some cases)
- Application only up to \$250,000 / No limit with financial statements
- New and used equipment OK
- Trade-In Capability
 - Always have the latest equipment
 - No additional money down
 - Keep or extend the terms
- Add equipment to your lease at any time (\$5,000 or more)
- Include: installation fees, software, service contracts, shipping, etc.
- No Personal Guarantee (in most cases)
- No Collateral (do not use your building as collateral for depreciating items)
- No Financial Statements (in most cases)
- Terms to 84 months
